District Engineer Report: Well 18: Water quality testing came back, and everything looks good. TCP = ND, Nitrate < 1 ppm, Arsenic = 5.3 ppb. The SWB also wants alachlor, atrazine, simazine, and radium-228 so we will collect those tomorrow and then Curtis will need to get them a few more documents for the permit before they will authorize us to pump to the system. Well 13 – no updates from the last meeting. Well 17 – no updates from the last meeting. Solar Project – SiteLogiq is in the design phase. PG&E will inform the District regarding approval of Well 16. Sunshine – Staff is updating the plans and cost estimates and will forward them to the District and the Water Board. I wish you all a Merry Christmas and Happy New Year.
